# **Greetings**Background and Update

- Executive Board has developed bylaws and brought the organization current with California Secretary of State, IRS, and Franchise Tax Board.
- PTOM-Roseville is officially a tax-exempt, registered 501(c)(3)
   Nonprofit Public Benefit Corporation for public and charitable purposes.
- Some of the primary benefits are that contributions to PTOM are generally tax deductible and that we'll have the structure to be able to continue the PTOM for years to come.

#### Role of PTOM

#### What do we want PTOM to be?

- Currently no structure in place for either volunteering or member dues.
- Some PTOs have mandatory volunteer hours for each family, while others charge a membership fee.
- For remainder of 2022-23 school year, we have opted to forgo volunteer requirement or paid dues.
- We have also considered circulating sign-up lists for events to solicit volunteers on a less formal basis.

#### Treasurer's Report

- Total revenue from the Valentine's Cookie Event was \$330
- We have not yet settled expenses, but anticipate some non-cash "donations" have been incurred.
- PTOM Bank Account
  - We attempted to open a bank account in mid-January, but this required an amendment to the bylaws to clarify the name of the organization.
  - Have an appointment scheduled to finalize the account next week.
